21/31. To approve and sign the minutes of the meetin g held on 8th March 2021

The minutes were approved and signed as a true record of the meeting.

Trees on the Main Road – They belong to Laws and Fiennes.

Trees in the Wykham Lane car park — They have been dug up by Cllr Mills and the Chair has filled in the holes.

Bench in Jubilee Gardens - The work has been done to sand and varnish the bench. The Chair has expenses to forward to the Clerk.

21/33. To receive an update on the defibrillator and cabinet

The defibrillator and cabinet were ordered and delivered. They are currently at the Clerks home address. A site meeting was held to discuss the installation. A suitable place with an electricity supply has been agreed between the pub landlord and electrician. It will be installed soon.

21/34. To approve the cost of a replacement village notice-board
